In FY 2025, 1050 individuals completed these training programs. BoardBuild also utilizes an algorithm based matching system to connect nonprofit boards and community leaders seeking specific skills, passion and expertise for nonprofit board leadership. In FY 2025 almost 100 community leaders were connected to nonprofit boards in communities around the country. Additionally, more than 300 local, regional and national nonprofit organizations posted open board positions using the BoardBuild platform, seeking to fill functional gaps on their boards and committees.
